The sports certificates of sportspersons as on the date of issue of notification achieved on or after 01.04.2022 shall only be considered for appointment. For this purpose, concluding day of the championship shall be taken into account. The sportsperson shall be an active player. Further, activeness in sports will be adjudged as per his/her performance during the trials.

All the recruitments shall be at the minimum of scale of Pay.

All the championships conducted under the aegis of recognized International/National/State Sports Federation and also recognized by the Railway Sports Promotion Board will only be acceptable.

Sportspersons having sports norms for higher levels of pay and apply against the vacancies for the lower Levels of pay, will also be considered, provided they will not claim for higher Level after joining the Railways on the basis of sports achievements prior to joining Railways and the candidates shall give an undertaking to this effect.

6. **RECRUITMENT PROCESS:** The recruitment will be based on performance during trials, assessment of sports achievements & educational qualification. The candidates who are found FIT in trials only will be considered for next stage of recruitment process.

7. (A) **SELECTION PROCEDURE:**

- (i) For this Recruitment, all eligible candidates will be called for the trials. Trials of the eligible candidates shall be conducted to assess the sports performance and suitability.
- (ii) The dates for trials will be notified later and published in the South Western Railway websites and will be held at Hubballi/Bengaluru/Mysuru or at any other notified places as decided by the Administration. While all out efforts will be made to inform the candidates well in advance, the candidates are cautioned that they may have to appear in the selection trials at short notice. The candidates are advised to regularly check the websites for information in this regard.
- (iii) Candidates should note that they are required to produce the originals of all documents enclosed with applications pertaining to educational qualification, caste, sports achievements, date of birth, minority income certificate and proof of identity viz. PAN card, Aadhar Card, Driving Licence etc. on the day of document verification and on the day trials failing which, the candidate will not be allowed to participate in the trials.
- (iv) Any request for change in dates/venue for trials etc **will not be entertained** under any circumstances.

(B) **Distribution of Marks:**

(a) Trial Committee shall give its recommendation in terms of either FIT or NOT FIT, for consideration for next stage of recruitment process, by giving marks (maximum 40 marks), as per the criteria given below:

(i)	For Game skill, physical fitness and Coach's observation during Trials	40 Marks

(b) After the trials, only the **FIT** candidates will be considered for the next stage of recruitment process. Candidates declared "NOT FIT" in the trials will not be assessed by the Recruitment Committee.

**8. EXAMINATION FEE/ EXEMPTIONS:**

(1)	The examination fee for all candidates except those mentioned in para (ii) below	:	<b>Rs.500/-</b> (Five Hundred only) with a provision for refunding Rs.400/- to those who actually appear in the trials.
(2)	For candidates belonging to SC/ST/Ex-Servicemen/Women/ Minorities/Economically Backward Classes (EBCs)	:	<b>Rs. 250/-</b> (Two Hundred and Fifty only) with a provision for refunding the same to those who actually appear in the trial.

- (i) While applying, the candidates claiming fee exemption must submit necessary certificates i.e. SC/ST/OBC/ Minorities / EBC, in the format prescribed (i.e. '**Annexure - A**', '**Annexure - B**' (along with **Annexure-B1**), '**Annexure - C**', '**Annexure - D**').
- (ii) Applications not accompanied with examination fee, wherever required, will be summarily rejected.
- (iii) Minorities will mean Muslims, Christians, Sikhs, Buddhists, Jains and Zorastrians (Parsis).
- (iv) Economically Backward classes means those candidates whose annual family income is less than Rs. 50,000/- per annum. The following are authorized to issue income certificate for the purpose of identifying EBCs: -
  - (a) District Magistrate or any other revenue officer up to the level of Tahasildar.
  - (b) Sitting Member of Parliament of Lok Sabha for persons of their own constituency.
  - (c) BPL card or any other certificate issued by the Central Government under a recognized poverty alleviation programme or Izzat MST issued by Railways.
  - (d) Union Minister may also recommend for any persons from anywhere in the country.
  - (e) Sitting Members of Parliament of Rajya Sabha for persons of the district in which these MPs normally reside.
  - (f) The income certificate issued by the authorities mentioned above would have to be in the format prescribed at '**Annexure - D**' which is available on South Western Railway Website. This would have to be issued on the letter head of the issuing authority.

**The examination fee should be paid in the form of crossed Indian Postal Order (IPO) only, from any Post office drawn in favour of Assistant. Personnel Officer/HQ., South Western Railway, Hubballi, payable at Hubballi.**

**8.1 Remittance of examination fee in any other form except Indian Postal Order will not be accepted.**

- (a) IPOs issued before the date of issue of Employment notice or after the closing date will not be accepted and the application will be rejected.
- (b) The particulars of Indian Postal Order submitted as examination fee should also be indicated at the prescribed place in the application form.
- (c) Candidates must write their name, full address in the space provided in the Indian Postal Order.
- (d) The examination fee is not refundable/transferable/adjustable under any circumstances.

**9. HOW TO APPLY:**

- 9.1** First, carefully read all the instructions given in the employment notification before filling the application form & ensure that you are eligible to apply.
- 9.2** Application as applicable as per the '**Annexure – I**', '**Annexure – I(a)**', '**Annexure – I(b)**', '**Annexure – (c)**', '**Annexure – (d)**' (along with '**Annexure – II**'), shall be submitted on A-4 size good quality paper. The Application can be downloaded from the websites of Railway Recruitment Cell, South Western Railway, Hubballi ([www.rrchubli.in](http://www.rrchubli.in)) **OR** South Western Railway, Hubballi ([www.swr.indianrailways.gov.in](http://www.swr.indianrailways.gov.in)). The application should be filled in English or Hindi language only. **The applications in other than English or Hindi languages will be rejected.**
- 9.3** The application should be filled by the candidate in his/her own handwriting and signed (**Not to be signed in capital letters**).
- 9.4** The candidate has to affix/paste (not to be pinned/stapled) one recent passport size colour photograph without wig, cap or coloured glasses (not older than two months), duly attested/self attested by signing partially on the application and partially on the photo in the space provided for the purpose. Candidate is also required to enclose one extra passport size photograph (same as the one affixed/pasted on the application) along with the application.
